

CORPORATE CHALLENGE GAMES

RULES

1. Entry fee is \$100.00 per team.
2. Prizes – Total entry fees will be split 50/50. Half will go to The Linn County Fair Linn Dunn Memorial Building Fund and the other half will be donated to the top three winning teams' favorite 501C3 charities. A traveling trophy will also be awarded to the winning team. The trophy may displayed at their location, but must be returned by the beginning of the 2011 fair to be awarded to that year's winning team. An engraved plaque on the trophy will list winning team name and the year they won.
3. Each team will consist of **at least 6** individuals and **no more than 20**. The number of members on your roster will be set when the entry form is submitted. After the form is received, no more names may be added. Names can be changed, however, up until the first day of the fair when competition begins. Special circumstances will be addressed at the fair if need be.
4. Each team member must participate in at least one competition.
5. A company may have more than one team, provided each team pays the entry fee and each person is only on one team.
6. Although people who work for the same company are encouraged to enter; friends may form a "bogus corporation" in order to enter and compete as long as all other rules are followed.
7. The contest will consist of 7 separate competitions, each awarding points.
 - a. Trivia Contest
 - b. Obstacle Course
 - c. Bean Bag Toss
 - d. Milking Contest
 - e. Eating Contest
 - f. Water Balloon Volleyball
 - g. Digital Scavenger Hunt
8. Extra points can be earned by –
 - a. Entering a float or unit in the parade – 50 points
 - b. Volunteering to work at the fair either before or during the fair – 1 point/hour worked up until the end of the last contest. Volunteer hours worked will start counting from the time the entry fee has been received. Volunteers do not have to be a member of a team, but can have their hours counted toward a specific team.
9. The total number of points earned from all competitions, along with any extra points, will determine the winners of the Corporate challenge Games.
10. All competitions will be held during the fair (July 7-12, 2010) at the fairgrounds in Central City. All judges' decisions are final.
11. A meeting will be held in June at the fairgrounds to go over specific rules for the various competitions, draw parings for the competitions, and answer any questions. Each team must have at least one representative at the meeting, but all members are encouraged to attend.
12. The Corporate Challenge Games will be limited to 16 teams on a first come first serve basis.
