### **RULES:**

1. There is no age or resident restrictions to enter this contest.
2. There will be three divisions:
  - a. Division I – Mild Salsa
  - b. Division II – Hot Salsa
  - c. Division III – Fruit Salsa
3. One entry per division per person. (One mild, one hot, and one fruit salsa)
4. Each entry must be in a one pint glass jar with a screw-on lid
5. No labels on the jar.
6. Must be fresh salsa, no canned salsa allowed
7. Recipe printed on a 3” x 5” card **MUST** accompany each entry. These recipes may be published on the website, newspaper, cookbook, etc.
8. Salsa will be judged on
  - a) appearance/color
  - b) texture/consistency
  - c) aroma
  - d) taste/after taste
  - e) appropriate heat level
9. Public is invited to taste and vote for their favorite during the public tasting (about 3 pm)
10. You are responsible to pick up your jar that day after public tasting.

Winners announced after judging. People’s Choice award announced after public judging completed (around 4 pm).
